Government Order

The undersigned is directed to convey the approval of the Government of the People's Republic of Bangladesh for **Mr. Md Rezaul Karim, Joint Secretary**, Ministry of Environment, Forest and Climate Change, to participate in the Regional Workshop for Strengthening Collaboration on Phasing Down Dental Amalgam in the WHO South-East Asia Region, scheduled to be held from **13–14 July 2026** in **Bangkok, Thailand**.

2. This approval is accorded under the following terms and conditions:
- He is scheduled to travel to Thailand in connection with the above workshop, subject to flight availability and programme schedule;
 - The entire period of the visit, including travel and transit, shall be treated as on duty;
 - He will draw his pay and allowances in local currency. No part thereof shall be drawn in foreign currency;
 - The **World Health Organization (WHO)** will bear the round-trip economy-class airfare, accommodation, daily subsistence allowance (DSA), and other approved expenses related to his participation in the workshop. There shall be no financial involvement from the Government of Bangladesh;
 - The official will not stay abroad beyond the approved period (except for unavoidable travel time);
 - He shall report to his office immediately upon return; and
 - He shall submit a brief report on the events to the Administration-2 Section, Ministry of Environment, Forest and Climate Change, within seven (07) working days of his return.
3. This order is issued with the approval of the competent authority.
