Government Order

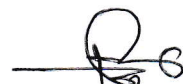
The undersigned is directed to convey the approval of the Government of the People's Republic of Bangladesh for **Mr. Tuhin Alam**, Assistant Director (Sirajganj District Office), Department of Environment to participate in the "Greenhouse Gas Inventories in Asia (WGIA23)", scheduled to be held from **03 to 06 August 2026** in **Brunei Darussalam**.

 - He shall not remain abroad beyond the approved period except for reasonable travel time;
 - He shall report to his office immediately upon return; and
 - He shall submit a brief report on the meeting to the Administration-2 Section, Ministry of Environment, Forest and Climate Change, within seven (07) working days of his return.
