Government Order

The undersigned is directed to convey the approval of the Government of the People's Republic of Bangladesh for **Mr. Mohammed Mostafijur Rahaman**, Veterinary Surgeon, Wildlife Management and Nature Conservation Division, Chattogram, Bangladesh Forest Department, to participate in the Regional Multi-country Training of Trainers (ToT) on the Joint Risk Assessment Operational Tool (JRA OT) for South-East Asia, scheduled to be held from **10-11 August 2026 in Kathmandu, Nepal**.

2. This approval is accorded under the following terms and conditions:
 - i. He is scheduled to travel to Nepal in connection with the above training programme, subject to flight availability and programme schedule;
 - ii. The entire duration of the visit, including travel and transit, shall be treated as on duty;
 - iii. He will draw his pay and allowances in local currency, and no part of it shall be drawn in foreign currency;
 - iv. The Food and Agriculture Organization of the United Nations Regional Office for Asia and the Pacific (FAO RAP) will bear the round-trip economy-class airfare and other approved expenses related to his participation in the meeting. **There shall be no financial involvement from the Government of Bangladesh;**
 - v. He shall not remain abroad beyond the approved period except for reasonable travel time;
 - vi. He shall report to his office immediately upon return; and
 - vii. He shall submit a brief report on the meeting to the Administration-2 Section, Ministry of Environment, Forest and Climate Change, within seven (07) working days of his return.
3. This order is issued with the approval of the competent authority.
