Government Order

The undersigned is directed to convey the approval of the Government of the People's Republic of Bangladesh for Mr. Md. The programme is jointly organized by the International Big Cat Alliance (IBCA) and the Government of Maharashtra, India.

2. This approval is accorded under the following terms and conditions:
- He is scheduled to travel to India in connection with the above-mentioned programme, subject to flight availability and programme schedule;
 - The entire duration of the visit, including travel and transit, shall be treated as on duty;
 - He will draw his pay and allowances in local currency, and no part of it shall be drawn in foreign currency;
 - The Government of India will bear the round-trip economy-class airfare, daily subsistence allowance (DSA), and other approved expenses related to his participation in the programme. **There shall be no financial involvement from the Government of Bangladesh;**
 - He shall not remain abroad beyond the approved period except for reasonable travel time;
 - He shall report to his office immediately upon return; and
 - He shall submit a brief report on the meeting to the Administration-2 Section, Ministry of Environment, Forest and Climate Change, within seven (07) working days of his return.
