- The official shall not stay abroad beyond the approved period, except for reasonable travel time;
- He must report back to his office immediately upon return; and
- A brief participation report must be submitted to the Administration-2 Section, Ministry of Environment, Forest and Climate Change, within seven (07) days of his return.

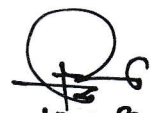
