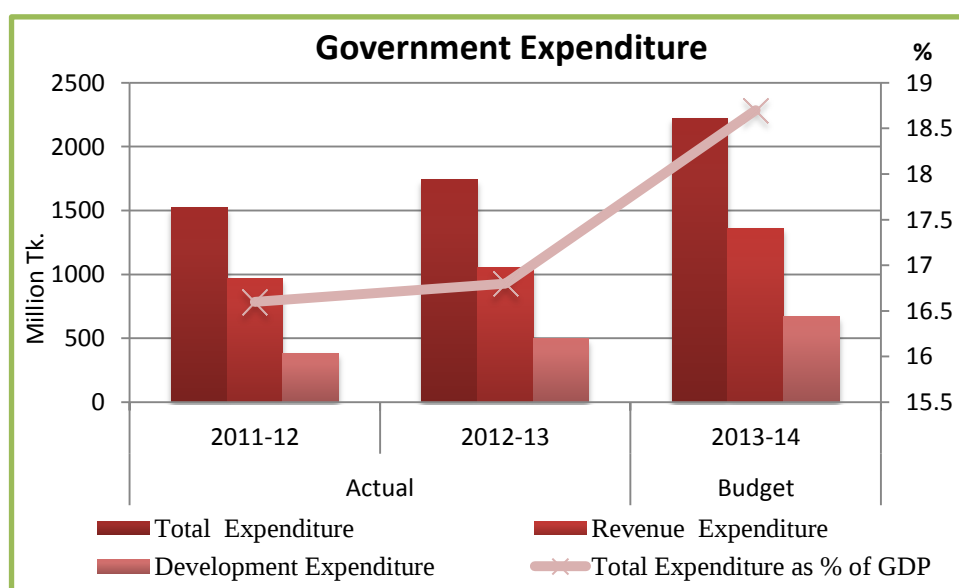

Executive Summary

***Fiscal Report is published on monthly basis.** The report basically contains information on government expenditure, revenue and overall balance. Data are collected mostly from the Integrated Budget & Accounting System (iBAS) of the Finance Division, Ministry of Finance. In this report, fiscal year (FY) refers to the time period covering from July 01 to June 30 of the next year. Taka is Local Currency Unit (LCU), and one crore means ten million.*

***Government expenditure** in Bangladesh is shown under two broad categories, namely, Non-Development Expenditure and Development Expenditure. Total non-development spending up to May 2014 in the current fiscal year (FY2014) is 73.5 percent of the budget estimates. Whereas, actual development expenditure during the same period amounts to 52.3 percent of the original development budget.*

***Revenue income** of the government comes from both tax and non-tax sources. For total revenue, up to May 2014, achievements as to revised annual target is 78.0 percent. During this period major share of the revenue comes from NBR (National Board of Revenue) sources (79.5 percent). Achievement of NBR tax revenue is 77.7 percent of the revised annual target. Revenue performance of NTR (Non tax Revenue) sources is also satisfactory. Up to May 2014, 79.4 percent of the revised annual target has been achieved.*

***Balance (Surplus/Deficit)** Overall balance of the budget is calculated either by including grants or by excluding grants. Up to May 2014, in current fiscal, as per revised estimate, overall balance (including grants) is -1.76 percent of the estimated GDP and excluding grants it is -1.88 percent of GDP.*

1.0 NON-DEVELOPMENT EXPENDITURE

1.1 NON-DEVELOPMENT EXPENDITURE: GENERAL CLASSIFICATION

1.1.1 SECTOR WISE ALLOCATION & GROWTH

Allocation under non-development expenditure against different Ministries/Divisions has been grouped into 14 sectors. Sector-wise utilization pattern and progress so far is presented in **Table 1**.

Some notable features are:

- Actual expenditure during FY13 was lower than the revised budget by 5.8 percent
- Compared to FY13, budget for FY14 is 30.0 percent higher than the actual expenditure and 20.8 percent higher than the original budget
- Budget allocation for FY14 has been increased over revised Budget of FY13 by 22.4 percent.
- Compared to FY13, increase in the allocation against General Public Services is the largest (41.8 percent) followed by allocation against Interest Payments (19.1 percent)
- As a whole, non-development spending up to May 2014 amounts to 73.5 percent of total non-development budget

1.1.2 BROAD SECTOR WISE ALLOCATION

Allocation under non-development expenditure against different ministry/division is also recorded under six broad categories namely Administration, Social Infrastructure, Physical Infrastructure, Agriculture, Interest Payment and others. Following table contains broad sector-wise information:

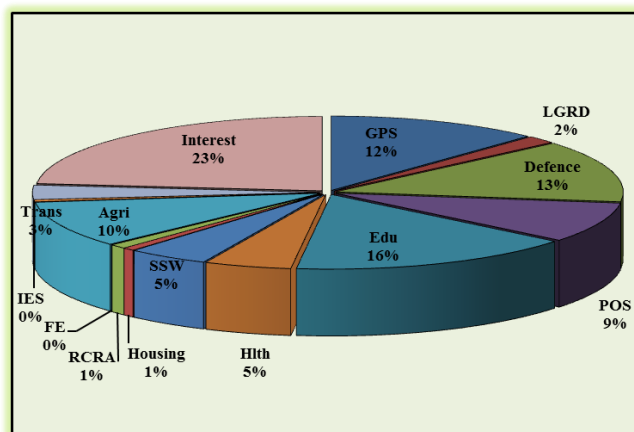

- Broadly in the budget for FY14 share of expenditure for administrative purpose has increased, whereas, allocations against all other categories are reduced in comparison to the actual expenditure during FY13
- Till May 2014, among all categories expenditure for administrative purpose is the highest

1.1.3 SECTOR SHARE IN RESOURCE UTILIZATION

Figure 1: Sector Share in Resource Utilization in FY14 (Up to May)

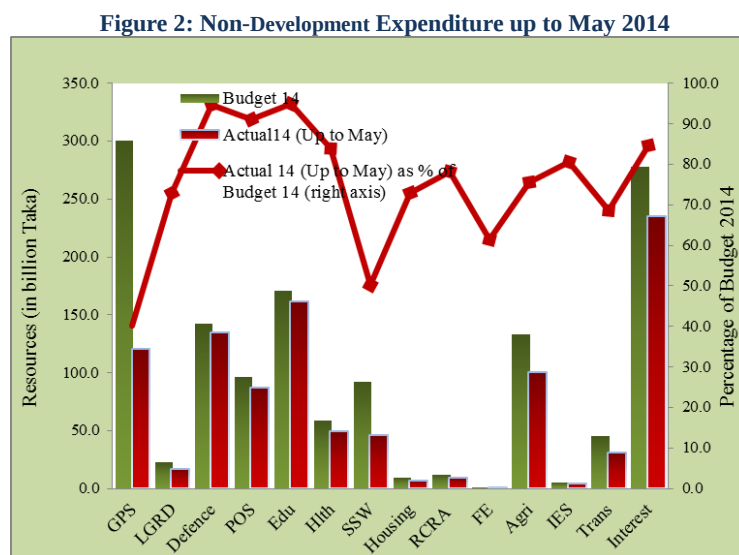


Total non-development spending up to May 2014 in the current fiscal year is 73.5 percent of the budget estimates. Sector-wise share in utilizing resources under non-development expenditure is shown in Figure 1.

- Individually the largest share goes to interest payment (23 percent) followed by education (16 percent), defence (13) general public service (12 percent), agriculture (10 percent), public order & safety (9 percent).

1.1.4 SECTOR-WISE UTILIZATION

For FY14 Sector-wise utilization pattern of non-development spending up to May 2014 is shown in **Figure 2**. This figure exhibits the comparative position of different sectors in terms of utilization of allocated resources. Apart from interest payment broadly education, general public service, defence and agriculture sector have shown better performance. Table containing detail data is annexed as **Appendix 1**.



1.1.5 MINISTRY-WISE UTILIZATION

For the current fiscal year actual spending (non-development) up to May 2014 is 73.5 percent of the budget estimate, which was 74.9 percent for the same period of the previous fiscal year. Ministry-wise utilization pattern of the non-development expenditure is presented in **Appendix 2**.

1.2 Non-Development Expenditure: Economic Classification

Budget allocation under Non-Development Expenditure is again categorized into 10 groups based on economic consideration, namely, Pay and Allowances (**PA**), Goods & Services (**GS**), Interest Payment (**IP**), Domestic Interest Payment (**DIP**), Foreign Interest Payment (**FIP**), Subsidies & Current Transfer (**SCT**), Block Allocation (**BA**), Acquisition of Assets and Works (**AAW**), Investment in share & Equities (**ISE**), Programme financed from Non-Development Budget (**PFNDB**). Status of actual spending up to May 2014 as per economic classification is shown in **Figure 3** and **4**. Detail structure & pattern of Non-Development Expenditure under this classification is included in the Appendix (**Appendix 3**).

- Up to May 2014, utilization rate of total non-development expenditure is 73.5 percent. As far as economic classification is concerned for some categories, like, pay and allowances (95.4 percent) and interest payment (84.5 percent) utilization rate is higher than average.

FY2014 (up to May 2014)**

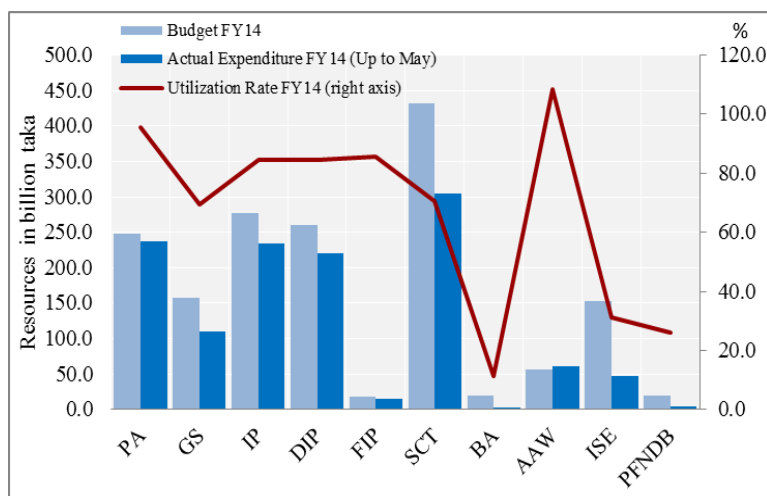
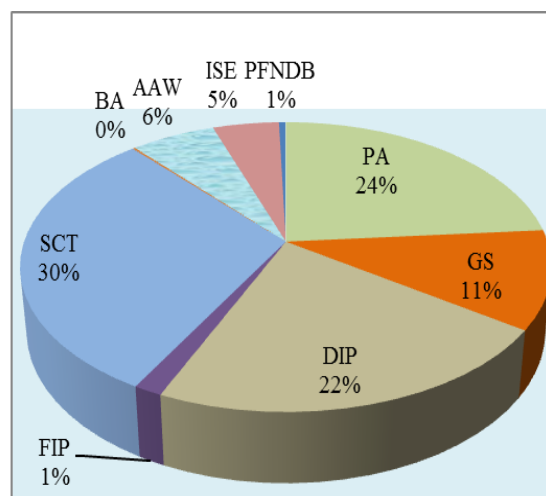


Figure 4: Share of Different Categories in Total Actual Expenditure FY2014 (up to May 2014)



2.0 DEVELOPMENT EXPENDITURE

2.1 ALLOCATION & UTILIZATION PATTERN OF DEVELOPMENT EXPENDITURE

Total amount allocated against different Ministries/Divisions for Development spending has been grouped under 13 broad sectors. Allocation and utilization pattern of **Development Expenditure**³ is shown in **Table 3**.

- Up to May 2014, actual development expenditure amounts to 52.3 percent of the revised development budget. This figure was 54.4 percent for the same period of the previous fiscal year
- Highest utilization is made in Recreation, Culture and Religious Affairs (68.8 percent) followed by Health sector (61.3 percent)

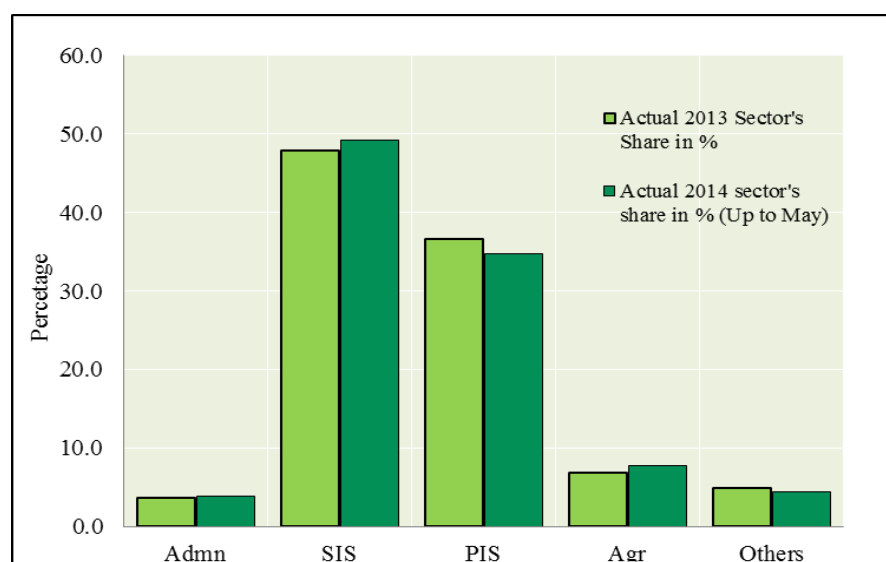
³ Development Expenditure includes ADP (Annual Development Programme) and Non-ADP FFW (Food for Work) and Transfers. Development expenditure is still under reported in the Budgeting Information System and it seems there is some time lag between actual expenditure and inputting the same in the system.

Total Development Expenditure has also been divided into 5 broad categories and status of the actual expenditure till May 2014 is presented in Figure 5.

➤ Spending up to May 2014 indicates that the maximum share has been spent for social Infrastructure (49.2 percent) and Physical infrastructure (34.8 percent)

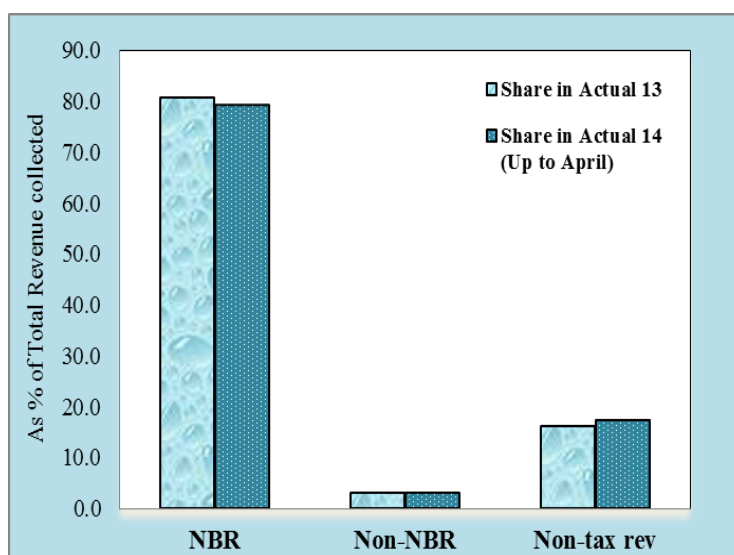

- **Total revenue** collection in FY13 was 12.3 percent of GDP and 91.7 percent of the budget target
- In FY14, total revenue is expected to be scaled up to 14.1 percent of GDP. This figure is about 20.0 percent higher than the revised budget estimates and about 30.7 percent higher than the actual collection in the FY13. In revised estimate, target for total revenue collection is set at 13.3 percent of GDP
- Up to May, 2014 total revenue collection for the FY14 registers 9.7 percent growth over the corresponding period of the previous fiscal year (FY13) and achievement as to revise annual target is about 78.0 percent.

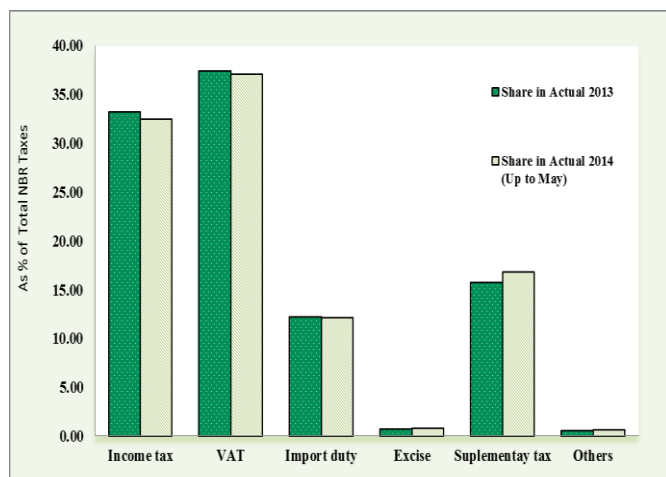
- Up to May 2014, major share of the government revenue comes from NBR sources (79.5 percent). Share of NTR in total revenue collection has increased to 17.2 percent compared to the 16.1 percent during the same period of FY13
- Growth rates of NBR & Non-NBR tax are only 8.3 and 10.5 percent respectively
- For NTR, 79.4 percent of the revised annual target has been achieved.

- In FY13 actual tax revenue collection was 10.4 percent of GDP
- Tax **revenue** collection target for FY14 was set at 11.9 percent of GDP. This is 20.9 percent higher than the revised budget and 31.4 percent higher than the actual collection of the FY2013. In the revised budget, tax **revenue** collection target for FY2014 is reduced to 11.02 percent of GDP

- In FY14 up to May 2014, major portion of the NBR tax comes from Indirect Taxes. Out of total NBR tax 32.4 percent comes from Income Tax and 37.4 percent from VAT.

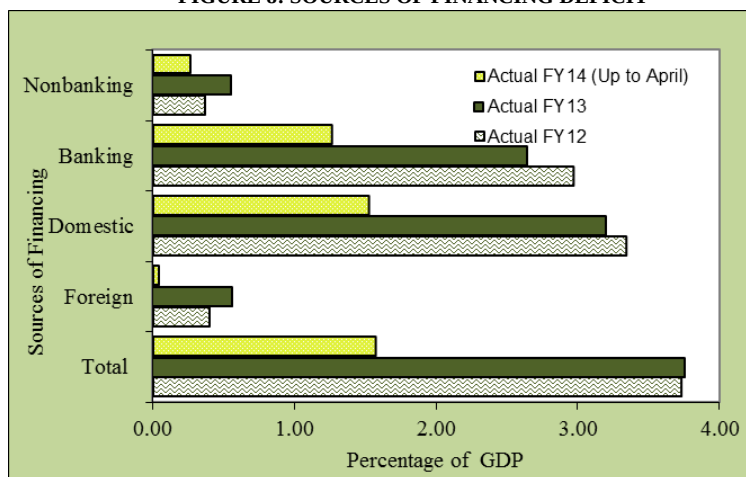
