02. Terms and Conditions :

- iv. The official will depart for Austria on 26 April, 2026 or the nearest possible date and return to Bangladesh on 29 April, 2026;
- v. No extension of stay beyond the approved programme duration will be allowed under any circumstances ; and
- vi. On return, the official is requested to submit a report on the above visit to the Secretary, Finance Division, within 15 (fifteen) days.
