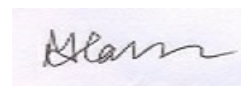
Subject: Government's Order

02. Terms and Conditions :

- iv. The officials will depart for Singapore on 23 August, 2026 or the nearest possible date and return to Bangladesh on 29 August, 2026;
- v. No extension of stay beyond the approved programme duration will be allowed under any circumstances ; and
- vi. On return, the officials are requested to submit a report on above training to the Secretary, Finance Division, within 15 (fifteen) days.
