- Advanced University degree in law with specialization in International Law, Settlement of International Disputes, Law of the sea or Law of International organizations.

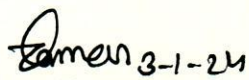
Work Experience:

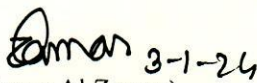

- Participating in international conferences and meetings.
