- (v) All the expenses to be incurred during the programme will be borne by Australian Awards Scholarship (AusAid);
- (vi) He is ineligible for applying for permanent residency and citizenship while studying abroad;
- (vii) All terms and conditions of Public Administration and Higher Education Policy-2023 and other related Rules and Regulations for training/studying abroad will be applicable.


