**2. Terms and conditions:**

- (iii) He will draw his pay and allowances in local currency as per Government's Deputation and Education Leave Rule (Half of average pay) of the Government expenses. No portion of his salary will be paid in Foreign currency;
- (iv) He will not be allowed to stay abroad more than the approved period;
- (v) After completion of his study, he will have to submit her joining letter in the Ministry along with Master's completion certificate, transcript and thesis paper;
- (vi) All the expenses to be incurred during the programme will be borne by AIMS@JCU Postgraduate Research Scholarship;
- (vii) He is ineligible for applying for permanent residency and citizenship while studying abroad;

All terms and conditions of Public Administration and Higher Education Policy-2023 and other related Rules and Regulations for training/studying abroad will be applicable.
