2. Terms and conditions:

- (i) The period of the program and the time to be spend for travel and salary will be treated as on duty.
- (ii) He will draw his usual pay and allowances from the Government of Bangladesh in local currency and no part of it will be paid in foreign currency.
- (iii) He will not be allowed to stay abroad more than the approved period.
- (iv) He will have to submit his joining letter along with a report of his Ph.D Program, Ph.D completion Certificate, Transcript and Thesis Paper to this Ministry.
- (v) All related expenses of the programme will be borne by Okayama University Research Grant Fund.
- (vi) He is ineligible for applying for permanent residency and citizenship while studying abroad.
- (vii) All terms and conditions under Public Administration and Higher Education Policy-2023 and other related Rules and Regulations for training/studying abroad will be applicable.


