4. All the documents submitted along with the application should be sent with attestation of the concerned Project Director; Otherwise, the application will not be accepted.
5. As the visa category is changed and extended on the basis of the recommendation of the concerned Ministry/Division, any violation of the conditions of A3 visa will be the liability of the concerned Ministry/Division.
