Subject: Government Order (G.O.) for Deputation.

The undersigned is directed to convey the Government's sanction of deputation to Md. Silton Ahmed (PN-100703), Staff Officer, Fire Service & Civil Defence Station, Manikganj (Attached: ICT Cell, Department of Fire Service and Civil Defence, Dhaka) for attending Master's program under the "Monbukagakusho: MEXT Scholarship" from 01/09/2026 to 30/09/2028 or for 02 (two) years from the date of commencement of deputation at Tokyo University of Science, Department of Global Fire Science and Technology, Graduate School of Science and Technology in Japan under the following terms and conditions:

- (1) Upon completion of his ongoing study leave from 01/09/2026 to 30/09/2028, he shall report for duty at the Directorate of Fire Service and Civil Defence;
 - (2) Total period of this program and the time spent for travel and transit will be treated as on duty;
 - (3) He will draw his usual pay and allowances from Bangladesh in local currency (BDT). No part of it shall be drawn in foreign currency;
 - (4) All expenses of the said course will be borne by the "Monbukagakusho: MEXT Scholarship and himself;
 - (5) He will not be allowed to stay abroad for more than the approved period;
 - (6) He will be ineligible to apply for permanent residency and citizenship while studying abroad;
 - (7) The provisions of the Public Administration Training and Higher Education Policy, 2023 (and its amendments) are applicable for this approval. Any application for further extension of the deputation period will be evaluated based on this policy;
 - (8) The provision of Rule 34 of BSR (part-1) will be applicable in connection of this approval;
 - (9) He will submit a report to the Ministry of Home Affairs within five days of his return to Bangladesh after completing the course;
 - (10) All terms and conditions of Public Administration Training and Higher Education Policy, 2023 and other related Rules and Regulations for training/studying abroad will be applicable.
2. This order is issued with the approval of the competent authority.

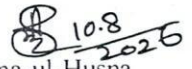
