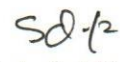

**Subject: Government Order (G.O) for Deputation.**

The undersigned is directed to convey the Government's approval of deputation allowing Mr. Muhammad Munirul Hasan (ID No. 152010030017, Passport No. E00227233), Deputy Director, Bangladesh Betar, Ministry of Information and Broadcasting, to attend a PhD Course under JICA's Knowledge Co-Creation Program for Long Term Participants on "Investment Promotion and Industrial Development for Asian Region (JFY2026)" at the Tokyo International University, Japan from 16/08/2026 to 30/09/2029 under the following terms and conditions:a.

- a. He will start his journey towards Japan on 16.08.2026 or a convenient date near 19.08.2026;
- b. Total period of this program and the time spent for travel and transit will be treated as on duty;
- c. He will draw all parts of his pay and allowances in local currency and not any part thereof in Foreign Currency;
- d. All expenses of the said course will be borne by Japanese JICA "Knowledge Co-Creation Program (KCCP) for Long-Term Participants (JICA Development Studies Program)" (JFY2026) Program Authority;
- e. The Duration of His PhD Course will be (03) Years 01 Month 15 days from 16.08.2026 to 30.09.2029;
- f. He will not be allowed to stay abroad for more than the approved period, the provision of Rule 34 of BSR (Part-1) will be applicable in connection with this approval;
- g. He will be ineligible to apply for permanent residency and citizenship while studying abroad;
- h. All terms and conditions of Public Administration Training and Higher Education Policy-2023 and other related Rules and Regulations for training/studying abroad will be applicable;
- i. He must submit an annual progress certificate from his research supervisor to the Ministry; failure to submit this certificate will result in the suspension of his salary;
- j. In the event of a failure to complete the course for reasons deemed acceptable by the authority, 1/5th (one-fifth) of the total amount of salary and allowances received during the period must be refunded to the government treasury;
- k. If the failure to complete the course is due to reasons not acceptable to the committee, the total amount of salary and allowances received during the deputation period must be refunded to the government treasury;
- l. If any allegation is found regarding violation of 'Academic Integrity & Ethics' at the host institution, departmental disciplinary action will be taken against him;
- m. He must submit a course completion report to the Ministry within 07 (seven) working days of his return to the country;
- n. After joining his current workplace, he must submit a report within 05 (five) working days.

2. This order is issued with the approval of the competent authority.

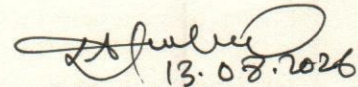
