

Notification

The undersigned is directed to convey the Government's approval of study leave on half of average pay to Mr. Mohammad Mahabub Alam (ID No. 16282), Officer on Special Duty (Deputy Secretary), Ministry of Public Administration from 01/01/2026 to 28/06/2026 for completing his PhD course at the Australian National University, Canberra, Australia under the following terms and condition:

- He will draw all his pay and allowances in local currency as per the Government's Education Leave Rule (Half of Average Pay). No part of it should be drawn in foreign currency;
- The Australian national University, Canberra, Australia or the participant himself will bear all related expenses of the said programme;
- He will not be allowed to stay abroad for more than the approved period;
- He will be ineligible to apply for permanent residency and citizenship while studying abroad;
- The provision of Appendix V and Rule 194 of BSR (Part-1) and provision of Rule 24 of BSR (Part-1) will be applicable in connection with this approval;
- He will submit a report to the Career Planning-2 Section of the Ministry of Public Administration within five days of his return to Bangladesh after completing the course;
- All terms and conditions of the Public Administration Training and Higher Education Policy-2023 and other related Rules and Regulations for training/studying abroad will be applicable.


