  - i. All terms and conditions of the Public Administration Training and Higher Education Policy-2023 and other related Rules and Regulations for training/studying abroad will be applicable;
  - j. He Must submit a report to the Career Planning-2 Section of the Ministry of Public Administration within five days after his return from/completion of the course.
