

- f. He will not be allowed to stay abroad beyond the approved period,
- g. He will be ineligible to apply for permanent residency and citizenship while studying abroad;
- h. The provision of Rule 34 of BSR (Part-1) will be applicable in connection with this approval;
- i. All terms and conditions of the Public Administration Training and Higher Education Policy-2023 and other related Rules and Regulations for training/studying abroad will be applicable;
- j. He must submit a report to the Career Planning-2 Section of the Ministry of Public Administration within five days after his return from/completion of the course.

2. This order is issued with the approval of the competent authority.


