 - i. He will submit a report to the Career Planning-2 Section of the Ministry of Public Administration within five days of his return from completing the course
 - j. All terms and conditions of Public Administration and Higher Education Policy-2023 and other related Rules and Regulations for training/studying abroad will be applicable.
