Subject: Government Order (G.O.) for Deputation

The undersigned is directed to convey the Government's approval of deputation to Ms. Sushmita Saha (ID No. 19266), (Passport No. E00266851), Assistant Secretary (Officer on Special Duty-Study Deputaion), Ministry of Public Administration to study the course of Masters in Basic Medical Science, University of South Alabama, USA from **13.08.2026 to 12.08.2027** under the following terms and conditions:

- a. She will start her journey toward the USA on a convenient date near 13 August 2026
 - b. The approved period of this program and the time spent for travel and transit will be treated as on duty;
 - c. She will draw all parts of her pay and allowances in local currency;
 - d. Frederick P. Whiddon College of Medicine, University of South Alabama will bear all expenses related to this study. The participant must abide by the conditions of the Scholarship;
 - e. **The Duration of her Masters course will be from 13.08.2026 to 31.05.2028 and the deputation period for the 1st year of the program is from 13.08.2026 to 12.08.2027;**
 - f. She will have to send a progress report to the Career Planning-2 Section every year from the concerned research supervisor;
 - g. The Deputation period will be renewed each year up to yearly completion of the Masters' program upon receiving the progress report from the supervisor;
 - h. She will not be allowed to apply for a PhD in the continuation of this masters' program;
 - i. She will not be allowed to stay abroad beyond the approved period and she must return after the completion of this masters' program;
 - j. She will be ineligible to apply for permanent residency and citizenship while studying abroad;
 - k. The provision of Rule 34 of BSR (part-1) will be applicable in connection with this approval;
 - l. She will submit a report to the Career Planning-2 Section of the Ministry of Public Administration within five days of her return from completing the course
 - m. All terms and conditions of Public Administration and Higher Education Policy-2023 and other related Rules and Regulations for training/studying abroad will be applicable.
