
Subject: Sanction of Earned Leave as Ex-Bangladesh Leave to Perform Holy Hajj.

With reference to the above subject, the undersigned is directed to convey the sanction of Ex-Bangladesh Earned Leave in favour of **Dr. Md. Abu Bakker Siddique (Passport No. A09753209), Chief Medical Officer, National Institute of Nuclear Medicine and Allied Sciences (NINMAS), Shahbag, Bangladesh Atomic Energy Commission** to visit Kingdom of Saudi Arabia (KSA) to perform Holy Hajj during 15.05.2026 to 13.06.2026 or 30 (thirty) days from the date of commencement of leave under the following terms and conditions:

- (a) All government instructions regarding the Holy Hajj must be followed;
- (b) The leave will have to be adjusted with his Earned Leave on average pay;
- (c) There will be no financial involvement from the Government/Commission;
- (d) During leave, he will draw his pay and allowances in Bangladeshi Currency and he will not demand financial support separately for this leave;
- (e) Prior to going on leave, He will have to hand over the charges with permission of the authority;
- (f) He will not stay abroad beyond the approved period; and
- (g) The Clause-34 from Appendix-8 of Rule-234 of BSR Part-1 will be applicable regarding this leave.
