- (a) Duration of the Program including the transit & travel time will be treated as on duty;
- (b) They will draw their pay and allowances in local currency. No part of it shall be drawn in foreign currency;
- (c) All expenses regarding this visit will be borne by Wuhan, Hubei province, P.R. China;
- (d) The Government of Bangladesh has no financial involvement in this visit;
- (e) They will leave Bangladesh for China on 26 August 2025 or on a nearest date and leave China for Bangladesh on 12 September 2025 or on a nearest date;
- (f) They will not be allowed to stay abroad more than the approved period; and
- (g) They will have to submit a report to the Ministry of Agriculture within 07(seven) working days after returning from the Program.
