
Subject: Enlistment of Sending Organization (SO) to send Skilled Workers to Singapore.

The undersigned is directed to inform you that the following agency is enlisted as a 'Sending Organization (SO)' on the basis of the application of the Bangladeshi NOC holder/partner to OTC, to send skilled workers to Singapore from Bangladesh in compliance with the relevant terms and conditions mentioned below:

Terms and conditions:

- i) The SO must send the bio-data of the qualified candidates, successfully passing in the tests conducted by the Building Construction Authority (BCA) of Singapore, only to their contracting receiving agency in Singapore. Visa/IPA obtained by the contracting Singaporean receiving agency against those candidates can only be accepted and processed for 'manpower clearance' from the Bureau of Manpower Employment and Training (BMET) Bangladesh;
- ii) The contracting receiving agency in Singapore can only procure Visa/IPA against the bio-data of the candidates received from their Bangladeshi counterpart SO. The contracting receiving agency in Singapore is not permitted to procure Visa/IPA for any candidate received from any other sources/agents;
- iii) The Local NOC holder/partners of the Singapore OTC must have updated NOC renewal and valid recruiting license; and
- iv) The Local NOC holder/partner of the OTC must comply with the Guidelines of OTC Management issued from the Ministry of Expatriates' Welfare and Overseas Employment of Bangladesh.
