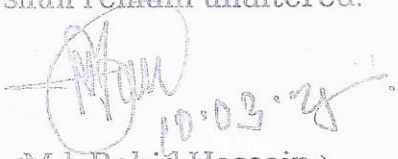

1	Invitation for Application (IFA) 19 (a) 2	If the applicants are the manufacturers or their authorized agent they must produce their product catalogue, leaflet or technical literature of the same with identification parameter such as DRP/DSPM No. / Part No. etc.	The applicant must have their official website with registration date and time. If the applicant have no website; they must produce their product catalogue, leaflet or technical literature of the same with identification parameter such as DRP/DSPM No. / Part No. etc. or else they must have Business Identification Number (BIN) so that their produced item could be identified.
2	Invitation for Application (IFA) 19 (a) 4	Bangladeshi Distributor/Traders could not Apply as Applicants; they would act as local agent of the Foreign Principle.	Bangladeshi Distributor/Traders can Apply as Applicants as per following condition: 1. PSI Agent must be appointed before shipping goods. The goods must be shipped after the PSI Certificate is issued by the PSI agent. 2. DCOS/Shipping/PHT must mandatorily unload and receive the goods. In this case the correct source and external quality of the goods must be verified. 3. In case of payment according to Condition of Tender Document E. Payment Terms of Annexure-B Payment at Sight: 80% and Payment on acceptance: 20% will be applied. 4. Bangladeshi Distributors are required to mandatorily quote the price of goods in Bangladeshi currency. In that context contracts and letter of credit will be established. 5. In the case of Bangladeshi Distributors, registration application must be submitted for multiple manufacturing companies through a single application.
