**SUBJECT: HOUSE WIRING LOAN**

**I. PURPOSE:**

This Instruction sets forth the terms and conditions for granting House Wiring Loans to the consumers taken over from other distribution entity and PBS consumers.

**II. POLICY:**

The process of extending house wiring loans to other distribution entity consumers taken over by PBS and to PBS consumers shall be governed as per the following guidelines:

1. Effectiveness	Loans to taken over consumers may be extended at the time of renovation of meters to meet the PBS standard.	The policies for extending house wiring loans to PBS consumers will become effective as and when directives from BREB have been received by the PBSs to grant such loans


Criteria of providing loan	House wiring loans to	
	Other distribution entity consumers taken over by PBS	PBS consumers
<b>2. Eligibility</b>	Only the valid consumers taken over from PDB/other Utilities are eligible for getting house wiring loan. In course of taking over of lines from PDB/other Utilities, consumers other than the valid consumers may also fall within the scope of take over. Such consumers are not entitled to receive house wiring loans.	Only the consumers of the PBS are eligible for getting house wiring loan.
<b>3. Loan amount</b>	Cost of house wiring materials for renovation as approved by BREB from time to time.  No cash loan will be allowed.	House wiring materials for a maximum amount as fixed by BREB may be provided.  No cash loan will be allowed.
<b>4. Materials as loan</b>	Materials to be supplied as loan will include only grounding rod, meter board and other items as approved by BREB.	Materials to be provided as loan will include the items as determined by BREB from time to time.


