SUBJECT:

Procedure for Selection of Apprentice Lineman Trainee Candidates, Including Development of Programs for Training and Career Opportunity for Line-crew Personnel.

BACKGROUND:

Since the inception of RE program, Directorate of training strives to have achieved the benchmark standard of training, The Lineman's training program is rigorous and intensive. It is a 03 (three) week hands-on program that prepares individuals for entry-level position as Apprentice lineman. In addition to perfecting their climbing skills, participants become proficient in various other lineman skills, while making safety their top priority. Trainees learn skill such as making connections of meters, installation of transformers, ACR/OCRs, Voltage Regulator and others electrical equipments on de-energized as well as energized line, along with framing and installation of poles and apparatus on the ground.

PURPOSE:

To establish and set forth a policy-guidelines to be implemented by the Palli Bidyut Samities for the purpose of selection of Apprentice Lineman Trainee candidates to provide them with the lineman Part-1 Training courses so that the qualified candidates in the Training course may become eligible for appointment as apprentice lineman on probation by PBSs where vacancies exist. Each PBS shall also develop a long-term policy for Training and Career Development program for PBS Line-crew personal with a view to attain the following objectives.

1. The primary objective of each PBS as well as BREB is to provide abundant, reliable and dependable Electric Service facilities to PBS consumer-members;

In order to best materialize this objective, the Electric distribution system of each Palli Bidyut Samity must be operated and maintained in a competent and efficient manner;

2. Proper performance of this job requires well-trained, highly skilled and reliable line-crew personnel;
3. A continuing program of training will necessarily be an integral part of a Line-crew personnel's job order to accomplish these objectives;
4. Line-crew personnel will be expected to continually improve in their knowledge, abilities and skills to a predetermined level of competency if they are to remain as an employee of any PBS and to

POLICY:

Each Palli Bidyut Samity shall adopt the following laid-down policies and procedures for selection of apprentice Lineman Trainee candidates including a uniform long-term Training programs and career development opportunity for PBS Line-crew personnel.

A. Procedure For Selection Of Apprentice Lineman Trainee Candidates.

According to the number of vacant post and trend of vacant post required number of Apprentice Trainee Lineman candidates with qualifications and aptitudes as stated below through advertisement in national daily news papers keeping in view the availability of quota approved by the government. The selected apprentice lineman trainee candidates will be given Part-I Lineman training. The successful candidates will be appointed in the PBS as Apprentice Lineman on probation/contract basis (The Procedure for Selection of Contract basis Lineman is enclosed here in with Annexure-A. Which may be Revised time to time by the prior approval of BREB). against vacant post. In case there is any surplus successful candidate who cannot be appointed in the PBS for lack of vacant post, then he may be appointed at the same status by other PBSs where vacancies as well as quota of the candidate exists.

1. Qualifications & Aptitude For Apprentice Lineman Trainee Candidates:

- Candidates must have minimum GPA 3.00 out of 5 in SSC or equivalent examinations (Science group will be preferred);
- Must have good physique with ability to do hard labor on elevated electrical or similar type of structure;
- Must have aptitude and willingness to do manual labor;

d) Willingness and ability to learn job;

e) Must have the following physical dimension;

- 1) Height : 5'4" minimum;
- 2) Weight : 110 Lbs, Minimum;
- 3) Chest : 30" normal and 32" expanded Minimum;

f) Must qualify in the following endurance test:

- 1) Have to finish a mini-marathon race for one mile within a maximum of 7 (seven) minutes;
- 2) Ability to pull the body at chest level for a minimum of five consecutive times on a parallel bar / ring;

g) Candidates having athletics sports back ground in school level shall be preferred;

h) PBS Meter Reader cum Messengers with requisite qualifications and aptitude shall be given preference but age limit must be within 18 to 21 years. The Selected trainee is eligible for appointment as apprentice lineman up to his 24 years age in PBS service.

i) Age: Minimum 18 years & Maximum 21 years on the last date of submission the application for selection the trainee. The success trainee is eligible for appointment as apprentice lineman up to his 24 years age in PBS service.

rate of Tk. 400.00 (Taka Four Hundred) only for each day of Training. For training in Dhaka City the daily Allowance shall be Tk. 500.00 (Taka Five Hundred) only each day of training. DA is reimbursable from the PBS(s) for where the trainee apprentice lineman has been selected. After the completion of theoretical and practical Training courses, BREB Training Directorate along with a representative from System Operation Directorate / Zonal Office shall conduct written & practical test and will be publish the results.

- iii) Lineman training will be organized by BREB Training Directorate utilizing it's optimum capacity of physical and human resources of BREB. PBSs, electrical consultants and related experienced stakeholders of RE Program at BREB and PBSs premises and /or any other suitable place(s). BREB training directorate will also insist to utilize pedagogy and andagogy from in-house and outsource. Such type of training may also be conducted by competent and related experienced individual/firm through outsourcing. BREB Training Directorate will overall monitor and/ or conduct training courses and conduct final examination along with a representative from concern System Operation Directorate/Zonal Office. The provisional result shall be published in the same day of examination. BREB Training Directorate shall publish final and formal result afterward.

iv) **Employment Procedure for Selected Candidates.**

- a) About 40 (Forty) number of Apprentice Trainee Lineman candidates will select keeping in view the availability of district & other quota approved by the government. The selected Apprentice Lineman Trainee candidates will be given part-I (TL010) lineman training.
- b) Concerned sponsor PBS will pay the fee and other allowances for the trainee(s) participating in lineman part-I training against the vacant post of that PBS issue appointment letter in favor of the successful candidate(s).
- c) The successful candidates may be appointed in the PBS as Apprentice Lineman on probation basis against the vacant posts. In case there is any surplus successful candidate who cannot be appointed in the PBS for lack of vacant post, then they may be appointed at the same status by other PBSs where vacancies as well as quota of the candidate exists.
- d) The tenure of service of line-crew personnel as Apprentice lineman on probation shall be a minimum of one year period which however may be extended for maximum 6(six) months but such extension will not be more than two times, depending on the incumbent's job performance.

In order to achieve the objectives as stated in this Policy Instructions, a program of training courses designated to progress simultaneously with and to complement the work experience of the Line-crew personnel is to be conducted by BREB/PBSs. Each line-crew personnel will be required to participate in the prescribed training courses as will be designed from time to time by BREB/PBSs. The training courses for PBS Line-crew personnel shall be planned and administered by the Training Directorate with the assistance of System Operation Directorate of BREB. In planning the training courses, expressed needs for training by the PBSs based on actual operational experience will play an important part in determining the content of the training program. A broad guideline highlighting the training and career development programs and policies for PBS Line-crew-personnel is enumerated below for proper implementation and guidance.

1. Line crew personnel shall, after the successful completion of Patr-I Lineman Training Course, be recruited in a PBS as an Apprentice Lineman on probation. He will remain as an Apprentice Lineman on probation for a minimum period of 1 (one) year, which however may be extended for maximum 6(six) months but such extension will not be more than two times, depending on the incumbents job performance.
2. Upon the successful completion the minimum specified period as Apprentice Lineman, Line-crew personnel shall be

After completion of 03 years service as Lineman Grade-2, his salary will be fixed at the initial step of Salary pay grade No-5 of the PBS.

3. Upon successful completion of Part-II (TL 020) Lineman Training Courses and after working a minimum of 03 (three) years period as a Lineman Grade-2, a line-crew personnel may be promoted as a Lineman Grade-1 provided other requirements are satisfactorily fulfilled. A line crew personnel shall remain as a Lineman Grade-1 for a minimum of 3 (three) years for next promotion. A Lineman Grade-1 shall be offered Part-III (TL 030) Lineman Training Course after he gains a minimum of 06 (six) months work experience as Lineman Grade-1.
4. Upon successful completion of Part-III (TL 030) Lineman Training Courses and after working a minimum of 3 (Three) years as a Lineman Grade-1 (subject to the condition the total service length is not less than 10 years) a line-crew personnel may be promoted as a Line Technician against the vacant post provided other requirements are satisfactorily fulfilled. A Line-crew personnel shall remain as Line Technician for a minimum period of 05 (five) years for next promotion. A line

Technician shall be offered Part-IVA (TL040, Part-IVB (TL042, Part-IVC (TL044) specialized Training Course as the need arises for this type of knowledge and skill provided he gains a minimum of 06 (six) months work experience as Line Technician.

5. A lineman Grade-2/ Grade-1/Line Technician may be offered Part-IIIA (TL031) specialized training course as the need arises for this type of knowledge and skill. TL031 course is not a mandatory training course and it will not be affected on his promotion or time scale at any stage in his service.
6. Upon successful completion of Part-IVA (TL040), Part-IVB (TL042, Part IVC (TL044) specialized Training Courses and after working a minimum of 05 (five) years as Line Technician, a line-crew personnel shall qualify for appointment as Assistant Junior Engineer (O&M/E&C/P&M) against the vacant post(s) as per their quota provided other requirements are satisfactory fulfilled and his total work experience is not less than 19 (Nineteen) years. This promotion/ appointment will be made as per PBS Employee service rule, 1992 (amended 2012) & PBS Instruction 300-14.
7. Moreover, Some of the selected Lineman shall be trained for Hot Line Equipment Operation and on successful completion of Hot Line Equipment Training will designated as Hot Stick Lineman and Transformer Hot Stick Lineman.

C. Training Facilities for Career Development.

1. A line-crew-personnel's increase in Grade and pay will in part be based upon the respective incumbents training record. The incumbent will be evaluated on his training performance and record of this is to be kept in his permanent file for future reference.

The training program will be a continuing one through a prescribed period of years to bring the PBS line crew personnel to the Grade of Asst. Junior Engineer (O&M/E&C/P&M). An outline of this program is enumerated below.

- a) Organized and formal training activity will be interspersed at regularly scheduled intervals along with the employees regular work-activity.
- b) Training will be so scheduled that during subsequent work-time, a line crew personnel be able to make application of the practices and skills learned during his training period.
- c) It is anticipated that a good line-crew personnel will be able to reach the Grade of Line Technician by 10 (ten) years and of Assistant Junior Engineer by 19 (Nineteen) years of satisfactory performance with the PBS.
- d) Training, job assignments and employment expectation will progress at a rate in keeping with the incumbent's ability to become proficient in such knowledge and skills.
- e) A line crew personnel will not be required to perform the more hazardous duties until he has properly trained (through formal training and work experience) for his job.
- f) A line crew personnel, in discharging his job, shall have to practice safety rules strictly. Safety instruction will be a continuing part of line crew personnel training at all levels.

- g) The PBS may be expected to provide certain training facilities during the training program and as called upon to do so by the BREB Training Directorate.
- h) It will be the option of the PBS to decide when the line crew personnel are ready for his next phase of training within the minimum limits previously stated. (Not less than six months work experience in the preceding Grade).
- i) Each PBS will determine the time of advancement of the line crew personnel to the next Grade.
- j) Apprentice Lineman trainee candidate so selected for training shall become eligible for appointment as apprentice Lineman on probation only upon successful completion of Part-I (TL010) Lineman Training Courses. If any candidate fails in the Training Course, his eligibility for appointment shall be terminated.
- k) With the exception of anybody's inability to qualify in the Part-I (TL010) Lineman Training Courses, a line crew personnel who is un-successful in completing any particular phase of training will not be eligible for an increase in Grade and pay until waiting a reasonable length of time to be determined by the PBS and/or as per instruction 700-12 then repeating the particular phase of training and passing it.
2. In order to engage the PBS line crew in surveying/ preparing TSR & staking sheets/ performing other engineering jobs against the consumer's applications, or any other purposes, the training schedule (TL031) set forth for stackers following PBS instructions 100-21, 100-28, 100-45, Staking error to avoid etc. May be organized for selected regular PBS line crews, specially who will be posted under the Engineering and Construction Department
