Contract Agreement

THIS AGREEMENT made the 11th day of March, 2026 between **Superintending Engineer, Bangladesh Rural Electrification Board, Central Warehouse, Fouzderhat, Chattogram Zone, Chattogram, Bangladesh** (hereinafter called “the Procuring Entity”) of the one part and **Masud Paribahan Songtha, Shilonia Bazar, Joyloshkor Union Parisod, Dagonbhuiyan, Feni** (hereinafter called “the Supplier”) of the other part:
