Contract Agreement.

THIS AGREEMENT made the 9th day of March, 2026 between **Superintending Engineer, Chattogram Zone, BREB, Chattogram** (hereinafter called "the Procuring Entity") of the one part and **M/S M.H Enterprise, Road Nowdapara, House No. 92/A, Sopura, Shamukhdum, Rajshahi** (hereinafter called "the Contractor") of the other part:

WHEREAS the Procuring Entity invited Tenders for certain works, viz, **construction of 6.611 km 33 kv new overhead and 5.00 km existing line remove/re-installation from Chakaria grid to Banskali-3 under Chattogram PBS-1** and has accepted a Tender (Contract No. SE-CTG-PBS-1-33KV-LC-2025-26-04, Tender ID No. 1214948) by the Contractor for the execution of those works in the sum of **Taka 37,79,467.909 (Taka Thirty-seven lakh seventy-nine thousand four hundred sixty-seven point nine zero nine)** (hereinafter called "the Contract Price").
