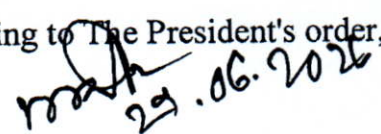
Government Order

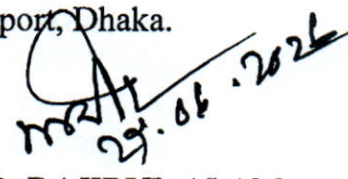
