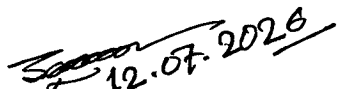
The undersigned is directed to convey the sanction of the government in favour of the following teacher for travelling to The United States of America for Research on Sabbatical Leave as mentioned below:

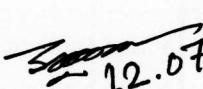
