

Government Order

Mr. Md. - (a) Total period of this programme and the time spent for travel and transit will be treated as on duty;
 - (b) He shall draw all his parts of his pays and Allowances in local currency and not in foreign Currency;
 - (c) He will not stay in Japan for more than the approved period without prior approval of the government.
 - (d) There will be no financial arrangement of the concerned organization or the government of Bangladesh;
 - (e) All the conditions stated in the bond Provided by the concerned officer will apply;
 - (f) Upon Completion of the Programme, he shall join the service of the authority within 05 (five) working days and submit the certificate awarded and a report on his programme within 07 (seven) days of Joining the work place.
