
**International Notice for Enlistment of**  
**(a) White Refined Sugar, (b) Refined Soyabean Oil/ Palm oil or any other Edible Oil, (c) Red Lentil, (d) Chick Pea, (e) Dates, (f) Onion & (g) CDSO**

Trading Corporation of Bangladesh (TCB) is a state-owned commercial organization in Bangladesh. TCB invites applications for enlistment from the potential suppliers/ firms from both home and abroad to participate in the International Tenders/ Quotations for importing (a) White Refined Sugar, (b) Refined Soyabean Oil / Palm oil or any other Edible Oil, (c) Red Lentil, (d) Chick Pea, (e) Dates, (f) Onion & (g) CDSO for the fiscal year 2024-2025 and 2025-2026. Applications addressing the undersigned, must be submitted on the letter head pad of the firms with following details and documents:

1. A brief overview of the firm;
2. Name of the Major Banks extending credit facilities;
3. List of the countries having strong bondage for sourcing (a) White Refined Sugar, (b) Refined Soyabean Oil / Palm oil, or any other Edible Oil, (c) Red Lentil, (d) Chick Pea, (e) Dates, (f) Onion & (g) CDSO.
4. Copy of the incorporation certificate;
5. Copy of the valid commercial (Import/ Export) License;
6. Copy of Tax/ VAT registration certificate;
7. Copy of the membership certificate of respective country's Chamber of Commerce/ Business Association;
8. Copy of the membership certificate of GAFTA (if any);
9. Copy of Letter of Credit and related documents against successful export/ supply of (a) White Refined Sugar, (b) Refined Soyabean Oil / Palm oil or any other Edible Oil, (c) Red Lentil, (d) Chick Pea, (e) Dates, (f) Onion & (g) CDSO or any other commodity items in the last one year;
10. Representative (if any) (Bangladeshi) submitting applications for their foreign principals must submit the letter of authorization from the concerned principals;
11. Representative (Bangladeshi) must submit attested photo copy of (a) National ID Card, (b) TIN Certificate, (c) VAT Certificate (If any) & (d) 3 copies of PP size photograph;
12. Selected suppliers/ firms must deposit Bank Draft/ Pay Order amounting to Tk- 5,000/- (Five Thousand) or USD 46 (Forty-Six) as enlistment fee separately for (a) **White Refined Sugar, (b) Refined Soyabean Oil/ Palm oil or any other Edible Oil, (c) Red Lentil, (d) Chick Pea, (e) Dates, (f) Onion & (g) CDSO** after final scrutiny.

**N.B.: 1. Applicant will have to apply separately to be enlisted for supply of (a) White Refined Sugar, (b) Refined Soyabean Oil / Palm oil or any other Edible Oil, (c) Red Lentil, (d) Chick Pea, (e) Dates, (f) Onion, & (g) CDSO. Suppliers/ Firms those who are already enlisted in TCB will have to apply again separately for enlistment. 2. TCB authority has the right to cancel the enlistment at any time without showing any reason. 3. This enlistment will not ensure to get the work order.**
