Subject: Notice of debarment.

Dear Sir,

You are the manufacturer and the supplier of 6 (Six) No., Under Ground Pipe Locator (UGPL) which you contracted with Titas Gas through international open Tender (IFT no. PD.2312/401-MECD/UGPL/RE, date:12/07/2021). We sent you Purchase order no. PD.2312/401-MECD/UGPL/RE, dated 24/07/2022. You and your local agent acknowledged the purchase order and sent copy us with seal and signature dated 7/08/2022. After acceptance of Purchase Order we have opened L/C No. 101722010092 dated 11/08/2022. We sent the LC to you dated 14/08/2023.

The Latest date of Shipment of the LC was 09/11/2022 and LC Expiry date was 30/11/2022. You failed to supply these materials as the above stipulated time. As per your request we amended L/C on 11/01/2023 and sent to you urgently for supply the said materials. The amended latest date of shipment (LDS) of L/C was 11/11/2022 and LC Expiry was 25/01/2023. You have again failed to supply the said materials. After you a long period of time you again requested Titas Gas for tripartate meeting. Titas Gas, you and your local representative have participated tripartate on line meeting dated 10/07/2023 and 31/08/2023. As per your request and desire we amended LC again through our management approval and sent to you dated 12/09/2023 and 01/11/2023. The Latest date of Shipment of the amended LC was 15/10/2023 and LC expiry was 30/11/2023. You again failed to supply of the said materials within specified time. The amended LC also expired on more than one month i.e 30/11/2023. Unfortunately no visual progress from your end have seen.

For your gross negligence and failure of supply of said materials, we issued a letter dated on 04/01/2024 mentioning that "according to our Purchase Order no. PD.2312/401-MECD/UGPL/RE dated 24/07/2022 Clause-2(a), (b) and Clause-9 your delivery time has been expired and you are liable to Liquidated Damage and forfeit the Performance Guarantee (PG) that lead to Termination of above Purchase Order" and also requested to you supply of contracted materials within 7 (seven) days after receipt of the letter.

After the time have been expired you again failed to supply the materials and no progress has been found. However, you and your local agent sent letter dated 12/01/2024 and 14/01/2024 that you have not received/ confirmed LC and LC amendments through Bank of America after more than 17 (Seventeen) month later. We obtained detail clarification regarding the matter of our LC opening bank and sent you dated 15/01/2024.

Our procurement process is time bound process. We also provided kind hearted support and co-operation to you to supply of the said materials. But your negligence and more than one year delay of the supply of contracted materials greatly hampered our procurement process as well as the operations activity.
