
This is to inform you that the Low Density Polyethylene (LDPE) Tape manufactured and supplied by you against Purchase Order no. PD.2312/397-MECD/EZ/TAPE dated 27-03-2018 and LC no. 101718010061 dated 02-04-2018 was not complied the technical specifications of the Purchase Order and became unacceptable to our Quality Inspection & Testing Committee.

We sent letters dated 16-04-2019, 12-05-2019, 30-05-2019, 30-06-2019, 08-08-2019, 19-08-2019 & 16-09-2019 requesting you to replace the defective Tape or refund us the claimed amount as per Warranty Clause of the Purchase Order. You neither replaced the supplied Tape nor refunded us the claimed amount.

As amicable settlement was not possible for your non cooperation, Titas Gas filed Arbitration against you at Honorable High Court Division of Bangladesh. You did not attend the Arbitration although Arbitration Notice was issued to you by e-mail, Diplomatic Channel and Courier Service.

Hence, this is to notify you that you are declared as ineligible to participate in further procurement procedure as per management decision of Titas Gas Transmission & Distribution Company Ltd., Bangladesh.
