
Subject: Government Order (G.O.) for Deputation.

- (a) He will draw all parts of his pay and allowances in local currency as per the government's deputation rules;
- (b) All expenses of this Ph.D program will be borne by the Missouri University of Science and Technology, USA. There is no financial implication of the Bangladesh Government in this program;
- (c) He will have to join the Department of Technical and Madrasah Education on time after the end of the deputation;
- (d) He will have to inform the Directorate of Technical Education and the Technical and Madrasah Education Division about the progress of his course/research every 06 (six) months through the Head of the Department/Supervisor;
- (e) He will not be able to change the subject in the Ph.D program without the permission of the authorities;
- (f) He must submit a copy of the Ph.D course completion report and certificate to the Technical and Madrasah Education Division after his return from/completion of the program;
- (g) He will not be able to stay abroad beyond the approved period; and
- (h) All terms and conditions of the Public Administration Training and Higher Education Policy-2023 and other related Rules and Regulations for training/studying abroad will be applicable.


