The Embassy of the Republic of Indonesia in Dhaka presents its compliments to the Ministry of Foreign Affairs of the People's Republic of Bangladesh and referring to the Note Verbale No. 488/SB/IV/2025 regarding the Proposed Agreement on The Grant Program of the Indonesian Aid Scholarship (TIAS) has the honour to inform that the Ministry of Finance of the Republic of Indonesia is offering **The Indonesian Aid Scholarship (TIAS) Batch II** for Civil Servants, Government Officers, and persons officially nominated by Bangladesh government of Bangaldesh.

TIAS Batch II is a fully-funded Indonesian Government Scholarship, which is part of Grant Provision Program aimed at supporting the achievement of Sustainable Development Goals (SDGs), particularly in the field of education, and as a **continuation of the spirit of the Asia-Africa Conference and South-South Cooperation** that aims to support the achievement of SDGs targets, especially in the education sector, with as follows:

1. TIAS Batch II offers a fully-funded **Diploma, Bachelor and Applied Bachelor, and Magister scholarship for Civil Servants, Government Officers and persons officially nominated by Bangladesh government**. There are 25 higher education institutions (university, polytechnic, institute) with hundreds of major options which candidates can choose.
2. The scholarship will cover Academic Selection Costs (for university)
  - a) Tuition Fee
  - b) Transportation Cost
  - c) Accommodation Support Cost
  - d) Health Insurance Cost
  - e) Settlement Allowance
  - f) Monthly Living Allowance
  - g) Research Support Cost
  - h) International Seminar Support Cost
  - i) International Journal Publication Support Cost
  - j) Learning Support Cost
  - k) Buddy Program Cost
  - l) Matriculation Cost
  - m) Indonesian Language Learning Support Cost
  - n) English Training Support Cost (for awardee in Bahasa Indonesia class only)
3. Candidates will undergo several steps of selection, which are **Administrative Selection** (by The Indonesian Embassy in Dhaka and Ministry of Education, Science, and Technology) and **Academic Selection** (Desk Study, Psychological Test, and Interview).

4. The steps of registration:
  - a) Candidates must request for an **Endorsement Letter** from the esteemed Bangladesh Government/ Ministry/Institution. There is no limitation to the number of candidacy nominations;
  - b) The esteemed Bangladesh Government/Ministry/Institution or the candidates shall send the Endorsement Letter alongside all required documents to the Indonesian Embassy in Dhaka via email [sosio.culture@indonesia-bd.org](mailto:sosio.culture@indonesia-bd.org);
  - c) Then, the Indonesian Embassy in Dhaka will create a TIAS Account for the candidates if all of the required documents are already completed;
  - d) Candidates shall upload it into the TIAS website <https://tias.kemenkeu.go.id/>;
  - e) Deadline of the registration is on 23 May 2025.
5. Important notes on required documents and regulation:
  - a) The requirements of Diploma, Bachelor and Applied Bachelor, and Master degree are vary. Candidates are encouraged to intensively read the **Booklet of TIAS Academic Year 2025/ 2026 (Batch II)** to find out more about the requirements and regulation;
  - b) All documents must be available in English (or translated in English);
  - c) Academic Certificate and Academic Transcript of candidates must be attested both Ministry of Foreign Affairs and Ministry of Education of the issuing country;
  - d) English Certificate Proficiency with is mandatory. Medium Instruction of English cannot be a substitute of English Certificate Proficiency.



## The Indonesian AID Scholarship (TIAS)

The Indonesian AID Scholarship Program, hereinafter referred to as the TIAS Program, is part of the Grant Provision Program aimed at supporting the achievement of Sustainable Development Goals (SDGs), particularly in the field of education, and as a continuation of the spirit of the Asia-Africa Conference and South-South Cooperation. The provision of Indonesian Government grants, as regulated by applicable laws, serves as a form of soft diplomacy to strengthen cooperation and friendship among partner countries.

The TIAS Program can also be utilized as a tool to enhance people-to-people contact, facilitate knowledge and cultural exchange, and is expected to strengthen Indonesia's position in international forums. The TIAS Program is a scholarship program aimed at human resource development in partner countries, specifically intended for government officials (non-active military personnel) and/or individuals recommended by their governments. Recipients of the TIAS Program will pursue education at higher education institutions in Indonesia.

TIAS offers a diploma, bachelor and master degree program for Civil Servants, government officers and persons officially nominated by the targeted government. This scholarship offers an unforgettable educational experience in Indonesia through studying at a well-known university and polytechnic as well as living experience in a multicultural and multilingual country. Through TIAS, students will enhance their intellectual standing, develop their competencies, and open wider professional opportunities, a foundation for post-college success especially for those who will contribute in public sector works upon returning to their home country.

## Scholarship Requirements

The requirements for prospective scholarship participants are as follows:

Preferably has at least 2 years of work experience as a government employee in their country.</li><li>9. Preferably holds an active passport valid for at least 18 months from the date of application.</li><li>10. Submission of a TOEFL ITP certificate with a minimum score of 477 or an IELTS certificate with a minimum score of 5.5 (prediction tests are allowed) for applicants from countries where English is not the primary language. <b>Please note</b> that applicants to Kelas Bahasa Indonesia are required to have English fluency as well.</li><li>11. Citizenship of a priority country.</li><li>5. Health test document (stating that applicants are both physically and mentally healthy)</li><li>6. Not registered as an active military member.</li><li>7. Not currently undergoing or scheduled for mandatory military service until the completion of the study period.</li><li>8. Preferably holds an active passport valid for at least 18 months from the date of application.</li><li>9. Preferably has at least 2 years of work experience as a government employee in their country.</li><li>10. Submission of a certificate of employment in the government sector or equivalent documentation.</li><li>11. ## Selection

The selection stage is divided into 2 stages:

- a. Administrative Selection/File Selection
- b. Academic Selection

### A. Administrative Selection

- Administrative selection is a process of checking the completeness of the documents required for scholarship registration, including (please note that all documents submitted must be in English):
  - a. Certificate of previous completion studies;
  - b. Transcripts;
  - c. Curriculum Vitae (CV);
  - d. Student Agreement\*;
  - e. Recommendation letter from the government of the candidate's country;
  - f. A TOEFL ITP certificate with a minimum score of 477 or an IELTS certificate with a minimum score of 5.5 (prediction tests are allowed) for candidates from countries where English is not the primary language. **Please note** that applicants to Kelas Bahasa Indonesia is required to have English fluency as well.
  - g. Valid passport;
  - h. Certificate or required documents shows employment status/ potential

employed in the government/ public sector after the completion of study.

- i. In the event that employment status is not a government employee, Priority country governments required to submit a certificate separately stating that prospective selection participants have the potential to work in the local government after following a certain study program or level of study (Example: prospective scholarship applicants for D4 study level and Professional Education at the Indonesian Health Polytechnic).
- j. Attach a letter/document stating good behavior and/or free from criminal records from the competent local authorities.
- k. Health certificate attested by a doctor
- l. Other required documents

\*) Submission of a **Student Agreement** is mandatory for applying TIAS, which contains at least the following substances:

- a. Commitment to completing studies according to the specified study period;
- b. Commitment to return and serve your home country after completing your study period;
- c. Commitment to cover losses in the form of refunding scholarship funds if awardee carry out actions that violate the contract stated at student agreement); and
- d. Others (please find the attached Student Agreement in this document);

- The results of the administrative selection will become the basis for universities/official schools to carry out the academic selection stages.

## B. Academic Selection

- Academic selection is a continuing series of administrative/file selection which at a minimum consists of the following stages:
  - a. Desk Study;
  - b. Psychological Test; as well as
  - c. Interview.
- A psychological test is a test carried out to measure aspects of an individual's psychological abilities and their relationship to the individual's intellectual, interests and talents in the field of education.
- The interview test is a question-and-answer process carried out by interviewers from universities/official schools to Scholarship Selection Participants in order to collect certain data or information that. The aim is to obtain an idea of whether or not the selection participants are eligible to receive a scholarship.
- Apart from psychological tests and interviews, an Academic Potential Test (TPA) can be carried out which aims to determine the talents and abilities in the academic or scientific fields of Scholarship Selection Participants.

TPA will be carried out optionally depending on the policies of each study program/university.

- Official universities/schools will determine the standards for passing the academic tests for scholarship selection participants.
- The entire series of academic test processes will be carried out individually online by universities/official schools.
- The results of academic selection will be announced through web address: [www.tias.kemenkeu.go.id](http://www.tias.kemenkeu.go.id).

## Placement

Placement of Awardee is a series of processes consisting of:

- a. Making a Student Declaration, stating that prospective student agreed to be TIAS awardee;
- b. Engagement Process (Grant Agreement) with grant recipient countries;
- c. Administrative Registration at the intended College; as well as
- d. Departure.

In the event that the prospective awardee agrees to receive a TIAS scholarship, the selection participant is required to sign a **Student Declaration**.

## Return

- Repatriation is the process of returning foreign students to their home country and is carried out in the event of:
  - a. Have completed the study period, whether or not they have passed the deadline or duration of study according to the level of study taken.
  - b. Have passed the study program, either graduating early or in accordance with the study duration of the level of study taken.
  - c. Have participated in the graduation procession, the implementation time of which does not exceed the duration of the study period/does not exceed the new academic year. In the event that the graduation procession is held beyond the duration of the study period, awardees are not required to return to their home country and do not attend the graduation ceremony.
- The study period is the deadline/duration for the awardee to be able to be in Indonesia with the status of having successfully graduated and/or failed to graduate.
- Passing the study program is the scholarship recipient's success in studies as proven by documents in the form of:
  - a. Diploma or certificate of completion of studies;
  - b. Transcripts; and/or

- c. another document that substantively states that the Scholarship Recipient has completed the entire study process and can leave the university/official school where they are studying.
- d. The graduation date of the Scholarship Recipient is determined in the document as referred to in point (c)
- e. In the event that the graduation date is not listed/cannot be determined in the document as intended in point (d), the determination of the graduation date can be based on when the Scholarship Recipient:
  - 1. have completed all courses;
  - 2. has submitted the final assignment;
  - 3. has carried out the final assignment trial;
  - 4. have document official a kind of lettergraduation statement;
  - 5. when the grades for all courses correspond to passing standards have been go out;
  - 6. statement letter from the competent authority at the university/official school; and/or
  - 7. have graduated.
- f. The duration for the return of students is a maximum of 30 (thirty) calendar days after the student is declared to have graduated and must not exceed the duration of the residence permit stipulated.

## **Awardee's Rights and Obligations**

---

### **Rights**

Awardee are entitled to:

- a. Obtain status as an Indonesian AID scholarship recipient;
- b. Obtain rights in accordance with applicable provisions regarding Indonesian AID scholarships

### **Obligations**

- 1. Awardee carry out their obligations in accordance with the applicable provisions regarding Indonesian scholarships
- 2. Awardee have to:
  - a. Attend a series of lectures in accordance with the provisions applicable on campus;
  - b. Be of good character and comply with applicable laws and regulations in Indonesia;
  - c. Return and serve to your home country after completing your study period;
  - d. Fill out and complete the Agreement Letter process;

- e. Comply with the applicable regulations regarding the Indonesian AID scholarship (including that are stated in Student Agreement).

## Cancellation

Cancellation of Indonesian AID scholarship recipient status is carried out for the following reasons:

- a. Did not complete studies by (maximum duration):
  1. 3 (three) years from the start of the study period for Diploma;
  2. 4 (four) years from the start of the study period for Applied Bachelor or Bachelor;
  3. 2 (two) years from the start of the study period for Magister;
- b. Committing criminal acts that violate laws and regulations in Indonesia while studying; as well as
- c. Resignation for personal reasons; and
- d. Fail to comply with the applicable regulations regarding the Indonesian AID scholarship (including that are stated in Student Agreement and Student Declaration).
- e. Other reason classified as scholarship violation that are agreed by Indonesian government.

## Penalty

- Sanctions for Awardee can be given in terms of:
  - a. Forgery of documents;
  - b. Plagiarism;
  - c. Fraud; as well as
  - d. Violation of applicable rules and regulations regarding the Indonesian AID scholarship (including that are stated in Student Agreement and Student Declaration).
- Sanctions given can be in the form of:
  - a. Inclusion of awardees in the blacklist for granting Indonesian AID grants;
  - b. Exemption for universities/official schools from participating in the Indonesian AID scholarship program is for 2 years or until the decision of the Fund Management Unit.

## Force Majeure

Force majeure is an emergency situation and/or something that causes foreign students to be unable to continue their studies.

Force majeure can be described and is not limited to:

- a. Awardee died;
- b. The awardee is seriously ill (both physically and mentally) and is not covered by insurance/ non-treatable so he/she is unable to continue his/her studies;
- c. Natural and non-natural disasters;
- d. Other emergencies according to the results of joint decisions of Indonesian AID and respective counterparts;
- e. Awardees drop out before the study period is over;
- f. The awardee violates applicable laws and regulations, including that are stated in Student Agreement, that causing him to have to return to his country of origin.

Force majeure as referred to in points (a) to (d) causes the student to be returned to their country of origin which can be considered charged to the grant contingency costs.

The force majeure situation as referred to in points (e) and (f) causes the student to be returned to their home country which cannot be charged to contingency fees and should be bare by the awardee/ home countries representative


