

Section 1. Instructions to Tenderers

A. General

<p>1. 1. Scope of Tender</p>	<p>1.1 The Procuring Entity, as indicated in the Tender Data Sheet (TDS) issues this Tender Document for the procurement of non-Consulting Services as specified in the TDS and as detailed in Appendix A to the Contract. The name of the Tender and its number and identification is stated in the TDS.</p> <p>1.2 The successful Tenderer will be expected to complete the performance of the Services by the Intended Completion Date as stated in the TDS.</p>
<p>2. 2. Interpretation</p>	<p>2.1 Throughout this Tender Document:</p> <ul style="list-style-type: none">(a) the term "in writing" means communication written by hand or machine duly signed and includes properly authenticated messages by facsimile or electronic mail;(b) if the context so requires, singular means plural and vice versa;(c) "day" means calendar days unless otherwise specified as working days;(d) "Person" means and includes an individual, body of individuals, sole proprietorship, partnership, company, association or cooperative society that wishes to participate in Procurement proceedings;(e) "Tenderer" means a Person who submits a Tender;(f) "Tender Document" means the Document provided by a Procuring Entity to a Tenderer as a basis for preparation of the Tender; and(g) "Tender" depending on the context, means a Tender submitted by a Tenderer for execution of Works and physical services to a Procuring Entity in response to an Invitation for Tender
<p>3. 3. Source of Fund</p>	<p>3.1 The Procuring Entity has been allocated public funds as indicated in the TDS and intends to apply a portion of the funds to eligible payments under the Contract for which this Tender Document is issued.</p> <p>3.2 For the purpose of this provision, "public funds" means any monetary resources appropriated to the Procuring Entity under Government budget, or loan, grants and credits placed at the disposal of the Procuring Entity through the Government by the development partners or foreign states or organisations.</p> <p>3.3 Payments by the development partner, if so indicated in the TDS, will be made only at the request of the Government and upon approval by the development partner or foreign state or Organisation in accordance with the applicable Loan / Credit / Grant Agreement, and will be subject in all respects to the terms and conditions of that Agreement.</p>



<p>4. 4. Corrupt, Fraudulent, Collusive or Coercive Practices</p>	<p>4.1 The Government requires that Procuring Entities, as well as the Tenderers shall, during the procurement proceedings and the execution of Contracts under public funds, ensure-</p> <ul style="list-style-type: none"> a. strict compliance with the provisions of Section 64 of the Public Procurement Act 2006 including amendments thereto; b. abiding by the code of ethics as mentioned in the Rule 127 of the Public Procurement Rules, 2008 including amendments thereto; c. that neither it's any officer nor any staff or any other agents or intermediaries working on its behalf engages in any practice as detailed in the Rule 127. <p>4.2 If corrupt, fraudulent, collusive or coercive practices of any kind is determined by the Procuring Entity against any Tenderer alleged to have carried out such practices, the Procuring Entity shall:</p> <ul style="list-style-type: none"> a. exclude the concerned Tenderer from further participation in the particular procurement proceeding; or b. reject any recommendation for award that had been proposed for that concerned Tenderer; or c. declare, at its discretion, the concerned Tenderer to be ineligible to participate in further procurement proceedings, either indefinitely or for a specific period of time.
<p>5. 5. Eligible Tenderers</p>	<p>5.1 This Invitation for Tenders is open to all potential Tenderers.</p> <p>5.2 Tenderers shall have the legal capacity to enter into the Contract under the Applicable Law.</p> <p>5.3 Tenderers shall be enrolled in the relevant professional or trade organisations registered in Bangladesh.</p> <p>5.4 Tenderers may be a physical or juridical individual or body of individuals, or company invited to take part in public procurement or seeking to be so invited or submitting a Tender in response to an Invitation for Tenders.</p> <p>5.5 Tenderers shall have fulfilled its obligations to pay taxes under the provisions of laws and regulations of Bangladesh.</p> <p>5.6 Tenderers and all parties constituting the Tenderer shall not have a conflict of interest.</p> <p>5.7 Tenderer in its own name or its other names or also in the case of its Persons in different names, shall not be under a declaration of ineligibility for corrupt, fraudulent, collusive or coercive practices as stated under ITT Clause 4.2.</p>
<p>6. 6. Site Visit</p>	<p>6.1 Tenderers, at the Tenderers' own responsibility and risk, are encouraged to visit and examine the Site of required Services and its surroundings and, obtain all information that may be necessary for preparing the Tender and entering into a contract for the Services. The costs of visiting the Site shall be at the Tenderers' own expenses.</p>

7. 7. Tender Document	<p>7.1 The Sections comprising the Tender Document are listed below, and should be read in conjunction with any Addendum issued under ITT Clause 9.</p> <ul style="list-style-type: none">a. Section 1 Instructions to Tenderers (ITT)b. Section 2 Tender Data Sheet (TDS)c. Section 3 General Conditions of Contract (GCC)d. Section 4 Particular Conditions of Contract (PCC)e. Section 5 Tender and Contract Formsf. Section 6 Activity Schedule/g. Section 7 Performance Specifications and Drawing
8. 8. Clarification of Tender Document	<p>8.1 A prospective Tenderer requiring any clarification of the Tender Document shall contact the Procuring Entity in writing at the Procuring Entity's address and, within time as specified in the TDS.</p>
9. 9. Addendum to Tender Document	<p>9.1 At any time prior to the deadline for submission of Tenders, the Procuring Entity on its own initiative or in response to a clarification request in writing from a Tenderer, may revise the Tender Document by issuing an Addendum.</p> <p>9.2 The Addendum issued under ITT Sub Clause 9.1 shall become an integral part of the Tender Document and shall have a date and an issue number and must be circulated by fax, mail or e-mail, to Tenderers who have purchased the Tender Documents, within five (5) working days of issuance of such Addendum, to enable Tenderers to take appropriate action.</p> <p>9.3 If an Addendum is issued when time remaining is less than one-third of the time allowed for the preparation of Tenders, the Procuring Entity at its discretion shall extend the deadline by an appropriate number of days for the submission of Tenders, depending upon the nature of the Procurement requirement and the addendum. In any case, the minimum time for such extension shall not be less than three (3) working days.</p>



C. Qualification Criteria

10. 10. General Criteria	<p>10.1 Tenderers shall possess the necessary professional and technical qualifications and competence, financial resources, equipment and other physical facilities, managerial capability, specific experience, reputation, and the personnel, to perform the contract, which entails setting pass/fail criteria, which if not met by the Tenderers, will result in consideration of its Tender as non-responsive.</p> <p>10.2 In addition to meeting the eligibility criteria, as stated under ITT Clause 5, Tenderers must satisfy the other criteria stated in ITT Clauses 10 to 16 inclusive.</p>
11. 11. Experience Criteria	<p>11.1 Tenderers shall have the following minimum level of experience to qualify for the performance of the non-Consultant Service under the Contract:</p> <ul style="list-style-type: none"> a. a minimum number of years of general experience in contracting industries in public sector as Prime Contractor/Sub Contractor/Management Contractor as specified in the TDS; b. a minimum number of years of specific experience (to comply with this requirement service contracts cited should be at least 70 percent complete) as Prime Contractor in providing non-Consulting Service of a nature, complexity and methods/technology similar to the proposed non-Consulting Service in at least a number of contracts over the period, as specified in the TDS.
12. 12. Financial Criteria 13.	<p>12.1 Tenderer shall have the following minimum level of financial capacity to qualify for the performance of the Services under the Contract.</p> <ul style="list-style-type: none"> (a) the average annual turnover as specified in the TDS during the period specified in the TDS; (b) availability of minimum liquid assets i.e. working capital or credit line(s) from any scheduled Bank of Bangladesh, net of other contractual commitments, of the amount as specified in the TDS.
14. 13. Personnel Capacity 15.	<p>Tenderers shall have the minimum level of personnel capacity to qualify for the performance of the Services under the Contract consisting of key personnel with qualifications and experience as specified in the TDS.</p>
16. 14. Equipment Capacity 17.	<p>Tenderers shall own suitable equipment and other physical facilities or have proven access through contractual arrangement to hire or lease such equipment or facilities for the desired period, where necessary or have assured access through lease, hire, or other such method, of the essential equipment, in full working order, as specified in the TDS.</p>
18. 15. Joint Venture	<p>15.1 No Joint Venture (JV) shall be permissible under this Invitation for Tenders. Tenders submitted in the form of JV shall be considered non-responsive.</p>
19. 16. Sub-	<p>16.1 The successful Tenderer shall under no circumstances assign the</p>



contractor	services or any part of it to the Subcontractor(s).
D. Tender Preparation	
20. 17. Only One Tender	17.1 Tenderers shall submit only one (1) Tender for each package. Tenderer who submits or participates in more than one (1) Tender in one (1) package will cause all the Tenders of that particular Tenderer to be considered non-responsive.
21. 18. Cost of Tendering	<p>18.1 Tenderers shall bear all costs associated with the preparation and submission of its Tender, and the Procuring Entity shall not be responsible or liable for those costs, regardless of the conduct or outcome of the Tendering process.</p> <p>18.2 The Procuring Entity shall make Tender Documents available immediately to the potential Tenderers, requesting and willing to purchase at the corresponding price by the date the advertisement has been published in the newspaper.</p>
22. 19. Language of Tender	19.1 The Tender shall be written in the English language. Correspondences and documents relating to the Tender may be written in English or Bangla.
23. 20. Contents of Tender	<p>20.1 The Tender prepared by the Tenderer shall comprise the following:</p> <ul style="list-style-type: none"> a. Tender Submission Letter (Form PSN-1) as stated under ITT Sub Clause 21.1; b. Tenderer Information (Form PSN-2) as furnished in Section 5: Tender Forms; c. the Priced Activity Schedule as stated under ITT Sub Clause 21,22 and 23; d. the Tender Security as stated under ITT Clauses 26 and 27. e. the written confirmation authorizing the signatory of the Tender to commit the Tenderer, as stated under ITT Sub Clause 30.2; f. the Valid Trade License; g. documentary evidence of Tax Identification Number (TIN) and VAT as a proof of fulfilment of taxation obligations as stated under ITT Sub Clause 5.5; h. documentary evidence as stated under ITT Clause 24 establishing the Tenderer's eligibility and minimum qualifications required to be met for due performance of the physical services under the Contract; and i. Curriculum vita of proposed manpower in case of outsourcing manpower. j. for physical service, along with academic & experience certificate in case of supply of man-power (out-sourcing) as stated in section 6: Activity schedule.
24. 22. Tender	22.1 The Contract shall be for the Services, as described in Appendix A to the contract and in Section 7: Performance Specifications and

Prices		Drawing , based on the priced Activity Schedule , submitted by the Tenderer.
	22.2	The Tenderer shall fill in rates or prices inclusive of profit, overhead, Applicable Tax & VAT for all items of the Services described in the Specifications and listed in the Activity Schedule .
	22.3	The items quantified in the priced Activity Schedule for which no unit rates or prices have been entered by the Tenderer will not be paid for by the Employer when executed and shall be deemed covered by the other rates and prices in the Section 6: Activity Schedule .
	22.4	All kinds of applicable taxes, customs duties, fees, levies, VAT and other charges payable by the Service Provider under the Contract, or for any other cause, as of the date twenty-eight (28) days prior to the deadline for submission of Tenders, shall be included in the unit rates or prices and, the total Tender price submitted by the Tenderer.
	22.5	The price of a Contract shall be fixed in which case the unit rates or prices may not be modified in response to changes in economic or commercial conditions.
	22.6	In case of manpower supply, the remuneration of manpower shall be fixed as consolidated payment as per government circular plus applicable Tax & VAT. Tender shall quote only the commission as stated in section 6: Activity schedule .
	22.7	Tenderer's quoting rate of service commission of the Tender less the specific threshold specified in TDS & Section 6: Activity schedule of the Tender Document as stated under ITT Sub 22.6, shall be rejected .
25. 23. Tender Currency	23.1	Tenderers shall quote all prices in Bangladesh Taka (BDT) in the Tender Submission Letter and in the Activity Schedule .
26. 24. Documents Establishing Eligibility and Qualification of the Tenderer	24.1	Tenderers shall complete and submit the documentary evidence, as applicable to satisfy the following: <ul style="list-style-type: none"> (a) complete the eligibility declarations in the Tender Submission Letter (Form PSN-1); (b) complete the Tenderer Information (Form PSN-2); (c) general experience in service providing as stated under ITT Sub Clause 11.1(a), substantiated by the year of registration/constitution/licensing in its country of origin; (d) specific experience in service providing under public sector of similar nature and size as stated ITT Sub Clause 11.1(b), substantiated by Completion Certificate (s) issued by the relevant Procuring Entity(s);
27. 25. Validity Period of	25.1	Tenders shall remain valid for the period specified in the TDS after the date of Tender submission deadline prescribed by the Procuring Entity. A Tender valid for a period shorter than that specified shall be considered as

	<p>25.2 In exceptional circumstances, prior to the expiration of the Tender Validity period, the Procuring Entity may solicit all the Tenderers' consent to an extension of the period of validity of their Tenders; provided that those Tenderers have passed the preliminary examination as stated under ITT Sub Clause 39.2.</p>
	<p>25.3 The request and the responses shall be made in writing. Validity of the Tender Security provided under ITT Clause 25.2 shall also be suitably extended for twenty eight (28) days beyond the new date for the expiry of the Tender Validity. If a Tenderer does not respond or refuses the request it shall not forfeit its Tender Security, but its Tender shall no longer be considered in the evaluation proceedings. A Tenderer agreeing to the request will not be required or permitted to modify its Tender.</p>

Form of Tender Security</p>	<p>27.1 The Tender Security shall be at the Tenderer's option, be either in the form of a Bank Draft or Pay Order or Bank Guarantee issued by any scheduled Bank of Bangladesh and, shall remain valid for at least twenty eight (28) days beyond the expiry date of the Tender Validity.</p>
<p>30. 28. Return of Tender Security</p>	<p>28.1 No Tender Security shall be returned to the Tenderers before contract signing.</p>
<p>31.</p>	<p>28.2 Unsuccessful Tenderer's Tender Security will be discharged or returned as soon as possible but within twenty-eight (28) days after the expiry of the Tender Validity period as stated under ITT Sub Clauses 25.1.</p>
<p>32.</p>	<p>28.3 The Tender Security of the successful Tenderer will be discharged upon the Tenderer's furnishing of the performance security and signing of the Contract Agreement.</p>
<p>33. 29. Modification, or Withdrawal of Tender</p>	<p>34.1 Tenderers may modify or withdraw its Tender after it has been submitted by sending a written notice duly signed by the authorized signatory and properly sealed, and shall include a copy of the authorization confirmed by an affidavit authenticated by a Notary Public; provided that such written notice including the affidavit is received by the Procuring Entity prior to the deadline for submission of Tenders as stated under ITT Clause 32.</p>

Section 3. General Conditions of Contract

A. General

67. 1 Definitions

1.1 In the Conditions of Contract, which include Particular Conditions and these General Conditions; the following words and expressions shall have the meanings hereby assigned to them. Boldface type is used to identify the defined terms:

(a) **Approving Authority** means the authority which, in accordance with the Delegation of Financial Powers, approves the award of Contract for the Procurement of Goods, Works and Services;

(b) **Appropriate Authority** means the authority that gives decision on specific issues as per delegation of administrative and/or financial powers;

(c) **Completion** means the fulfilment of the Services by the Service Provider in accordance with the terms and conditions set forth in the Contract;

(d) **Completion Date** is the date of actual completion of the fulfilment of the Services certified by the Employer, in accordance with GCC Clause 49.1;

(e) **Contract Agreement** means the Agreement entered into between the Employer and the Service Provider together with the Contract Documents;

(f) **Contract Documents** means the documents listed in the Agreement, including any Addendum thereto, that is these General Conditions of Contract (GCC), the Particular Conditions of Contract (PCC), and the Appendices;

(g) **Contract Price** means the price to be paid for the performance of the Services, in accordance with GCC Clause 41.1;

(h) **Day** means calendar day unless otherwise specified as working days;

(i) **Effective Date** means the date on which this Contract comes into force pursuant to GCC Clause 11.1;

(j) **Employer** is the party named in the PCC who engages the Service Provider to perform the Services;

(k) **Force Majeure** means an event which is beyond the reasonable control of a Party, is not foreseeable, is unavoidable, and its origin is not due to negligence or lack of care on the part of a Party, and which makes a Party's performance of its obligations hereunder impossible or so impractical as reasonably to be considered impossible in the circumstances, and includes, but is not limited to, war, riots, civil disorder, earthquake, fire, explosion, storm, flood, epidemics, or other adverse weather conditions, strikes, lockouts or other industrial action (except where such strikes, lockouts or other industrial action are within the power of the Party invoking Force Majeure to prevent), confiscation or any other action by Government agencies. Force Majeure shall not include insufficiency of funds or failure to make any payment required hereunder;

(l) **GCC** means the General Conditions of Contract;

(m) **Government** means the Government of the People's Republic of Bangladesh;

(n) **Intended Completion Date** is the date on which it is intended that the Service Provider shall complete the Services as specified in the PCC;

(o) **Month** means calendar month;



### Background

#### 1. Project Background

Sustainable reintegration is a part of regular migration. It is a longstanding demand as well. The Overseas Employment and Migrants Act (OEMA) 2013, the Overseas Employment Policy (OEP) 2016, the Wage Earners' Welfare Board Act 2018, and the 8th Five Year Plan contains the provision to undertake reintegration program for migrant workers and their families.

The Covid-19 pandemic has crippled the global economic activities which caused the termination to a huge number of overseas jobs like construction, business, service, plantation and other sectors; so they are returning back to the home countries. According to Probashi Kallyan Desk, around 500,000 Bangladeshi migrant workers back home due to COVID-19 situation from March 2020 to June 2021. Before that remarkable number of returnee migrant workers are also back since 2015. Among them, the number of returnee women migrant workers is nearly 50,000. The opportunities are limited for the reintegration of returnee migrant workers.

The Ministry of Expatriates Welfare and Overseas Employment (MoEWOE) has taken initiative to set up a Reintegration Program for returnee migrants as part of a project titled "Recovery and Advancement of Informal Sector Employment (RAISE)" funded by the World Bank. The Wage Earners Welfare Board (WEWB), being an attached body of the Ministry will be responsible for implementing Components 3 (Reintegration of Returning Migrants) and Component 4.2 (WEWB project management and administration) as overall welfare service for Bangladesh migrant workers as part of their regular welfare activities.

#### 1.1 Objectives:

The overall goal and objective of this project is to create a sustainable reintegration model in holistic approach for Bangladeshi returnee migrant workers. The specific objectives of this project are:

## **1. Scope of Service:**

To have a clear idea/concept regarding welfare stream, knowledge sharing could be effective for taking further steps towards wage earners. In this connection study visit has been proposed in consultation with World Bank team. Study visit also be helpful for policy intervention. Participants select from MoEWOE- 02 persons, WEWB- 08 persons, ERD- 01-person, Socio-Economic Infrastructure Division- 02 persons, Programming Division- 01person, Implementation Monitoring and Evaluation Division- 01 person, a total of 15 persons and 10 days. The visiting country is Philippine. Considering the relevance of migration and overseas employment. Based on the experience the visit may be one.

Though the approved DPP provisioned was Philippine, however, the Project Management Unit (PMU) and WEWB, proposed the visiting country change in the Philippines. The World Bank task team has given their consent and has agreed to the change proposed in principle without changing the number of participants and days.

### **2.2 Directives for proposal by the consulting firms:**



**3. Qualifications of the Training/Visit Service Provider and Firm/ Institute****4.1 Training Service Provider**

The Visit/Training Service Provider shall be a reputable consulting/training firm/institute having extensive experience and capacity in conducting, managing and organizing Training/Visit in relevant fields in abroad. The TSP shall have at least 10 (ten) years overall experience in conducting overseas training/visit service for government of Bangladesh organizations and/ or international agencies. The TSP shall have adequate financial capability to provide the training service as per this TOR. The TSP shall be an international firm having an appropriate office and other facilities in Dhaka with adequate manpower to support the intended service.

**4.2 Training Firm/Institute**

The Training Firm shall be an internationally reputable and recognized training institute in the country of training having extensive experience in managing and providing training to the participants in the various fields. The Training Firm shall have at least 5 years overall and specific relevant experience.



#### 4.3 Professional staffs of Training Service Provider (TSP)

Professional staffs those who have past record of Fraudulent Practices/criminal record or committed crime that is currently under investigation will not be considered for evaluation.

#### 5. Duration of Contract

The duration of the contract to implement the overseas training program will be 3 months from the Effective Date of Contract. Extension of Contract will not be considered except in exceptional circumstances. The Effective Date of Contract shall occur on the date of concurrence of the contract by competent authority. This will be notified to the successful Applicant(s).

#### 6. Standards and Quality Assurance

The selected Training Firm/Institute to be engaged in foreign training shall comply with the highest standard of performance and quality assurance and professional ethics applicable to this type of assignment.

#### 7. RAISE Project's Obligation

The RAISE Project will provide all relevant information, available data, and existing documents related to training, as required by the TSP and/or Firm. The Project will render all necessary cooperation as and when required by the TSP/ Firm. In addition, the Project Director, of the RAISE project will be responsible for the following tasks.

135. To nominate the participants and obtain government clearance for the selected candidates for every course in time.

136. To cooperate with the TSP to assist them with academic documentation/medical certificates, and health certificates as required.

137. To cooperate with TSP/TF and provide all relevant information/ training data as required.

138. Review and approve the Visit plan and program.
139. Monitor and evaluate the performance of the TSP/TF.
140. To arrange timely payments to the Training Firm/ TSP as per provisions of the contract based on satisfactory performance.
141. Support for obtaining passports for the participants as required.

**142. Other Conditions**

The following shall be additional conditions applicable to the TSP. The training modules and number of participants may change subject to the future needs of RAISE. The TSP will be advised at least one month in advance of any proposed changes or rescheduling. In addition, the following shall apply:

1. The TSP shall submit an Inception Report and visit schedule within one week after the signing of the contract.
2. The physical execution of the visit shall commence within one month after the signing of the contract.
3. Establish a team of coordinators with the Team Leader and Administrative Officer with an office in Dhaka to liaise between the TSP's office and either client's office as and when required.
4. Depute suitably qualified and experienced local personnel as training course coordinators.
5. Monitor and support the various local and foreign visit/training programs.
6. Out-of-pocket expenses for trainees shall be as per GoB rules.
7. On successful completion of the courses, the trainees shall be evaluated in a suitable manner (e.g., examination, practical test, presentation).


**144. Mode of Payments**

**145. Evaluation and Award**

Applicants' technical proposals will be evaluated first to determine the technical score. The minimum qualifying mark is 70 out of 100 marks. The following criteria will be applied for technical evaluation: 1) experience of the TSP and the TF, 2) training infrastructure and organizational capacity, 3) the quality of the proposals regarding approach, methodology, and work plan, 4) qualification and experience of key staff.
