#### Job Description:

The Executive Director (Finance) is the Executive of the company reporting to the Managing Director. Subject to the supervision and approval of the board, the Executive Director (Finance) will be responsible for business development and ensuring the compliances of law, rules and regulations and for good governance. He is also responsible for supervision of all financial & welfare aspects, negotiation for project financing issues with donors/development partners and listing the company in the stock exchanges etc.

#### Qualification, Experiences and Age:

- At least Master Degree in Commerce/Finance/Accounting/MBA from any recognized University. CA/CMA will get preference.
- No third Division/Class at any stage of the academic career shall be acceptable. Candidates passed in the grading system must possess at least a CGPA 4.0 on a scale of 5.0 and a CGPA 3.0 on a scale of 4.0.
- At least 3 years experience in senior Managerial position in the relevant field (As DGM, Accounts/Finance or equivalent).
- At least 20 years of work experience in the relevant field of which 5 years in generation/transmission/distribution utilities.
- Must demonstrate knowledge in Govt. financial rules & regulations, PPA, PPR etc.
- Must demonstrate strong participatory leadership ability.
- Must be able to demonstrate in company law, labour law, TPM, TQM, Preventive Maintenance and Corporate Governance.
- Must have strong communication skill in Bengali & English (written & oral) including working experience using computer.
